**RESOLUTION #12.19E.11**

**A RESOLUTION IMPOSING SEWER RENTALS IN THE TOWNSHIP IN  
ACCORDANCE WITH SECTION 2511 OF THE SECOND CLASS  
TOWNSHIP CODE.**

**WHEREAS**, Ordinance 402.11 of Easttown Township permits sewer rentals to be set and modified by time to time by resolution of the Board; and


**WHEREAS**, the Township, in consultation with the Authority and the Authority's advisors, have determined that it is necessary to increase the rates of sewer rentals as presently charged in order that the Sewage System be operated on a sound financial basis and the debt incurred in connection with such system is properly and adequately secured and repaid as provided for in the Authority's Guaranteed Sewer Revenue Bonds, Series 2007 and the Township's rent payments due to the Authority under the Lease, which are dedicated to pay the debt service on the Authority's outstanding debt.

**NOW, THEREFORE**, it is hereby **RESOLVED** by the Board of Supervisors of Easttown Township as follows:


- Section 1. Multiple uses on a single property utilizing a single sewer connection shall be charged in accordance with Section 3b of Ordinance 134-95.
- Section 2. Rates and quarterly payments are established as follows: Base charge for each residential property on public water is increased from \$468.58 per year, payable in quarterly installments of \$117.15 each, to \$480.32 per year, payable in quarterly installments of \$120.08 each. Base charge for non-residential property is increased from \$518.79 per year, payable in quarterly installments of \$129.70 each, to \$531.76 per year, payable in quarterly installments of \$132.94 each.
- Section 3. For each residential property on public water, an additional sewer rental charge for all discharge into the sewer system in excess of 10,000 gallons for any three month period is increased from a rate of \$10.45 per 1,000 gallons to \$10.71 per 1,000 gallons; for each non-residential property, the said additional sewer rental charge for all discharge in excess of 10,000 for any three month period is increased from \$11.28 per 1,000 gallons to \$11.56 per 1,000 gallons.
- Section 4. For unmetered water usage the sewer rental charge of \$706.24 per year, payable in quarterly installments of \$176.56 each, is increased to \$723.88 per year, payable in quarterly installments of \$180.97 each.
- Section 5. The rates imposed hereby, shall be effective for all sewer rate charges incurred for sewer service on and after January 16, 2012.




